#### **Show Hours:**

Judging will begin at 8:00 a.m. Saturday. Trial 2 will start immediately following the completion of Agility I, Trial 1, but no earlier than 8:30 a.m. Judging will begin at 8:00 a.m. Sunday. Trial 2 will start immediately following the completion of Agility II, Trial 1, but no earlier than 8:30 a.m. Building opens at 7:00 a.m. Saturday, 7:00 a.m. Sunday. You must check in before judging starts for your class. Check in begins at 7:30 a.m. Saturday, 7:30 a.m. Sunday.

#### **Move Ups:**

Dogs finishing a title on Saturday may move up to the next higher class on Sunday. **No move-ups will be allowed on Saturday between Trial 1 and Trial 2. No move-ups will be allowed on Sunday between Trial 1 and Trial 2.**

#### **Jump Height Divisions:**

Division Toy (4") Dogs up to and including 10" at withers.  
Division 1 (8"): Dogs over 10" & up to & including 14" at the withers.  
Division 2 (14"): Dogs over 14" & up to & including 20" at the withers.  
Division 3 (20"): Dogs over 20" at the withers.

#### **Awards:**

Ribbons will be awarded for all qualifying scores and for first through fourth placements in each size division. Prizes will be awarded to the highest scoring dog in each division. Prizes and rosettes will be given for High in Trial. Additional awards and prizes may be available on the day of the trial. Highest Scoring Junior will be awarded in each trial. Ribbons and prizes for Placements, High in Trial, High Combined and High Junior that are not picked up by exhibitor by the close of the show Sunday will be forfeited.

#### **Attention Exhibitors:**

- Electronic timers will be used during all trials.
- Bitches in season cannot compete. HATT will refund 50% of entry fee for any competitor who provides a veterinarian certificate verifying that the female came into season after the closing date. Certificate may be mailed, provided that the postmark is no later than the day prior to the day of the trial, or delivered by hand to the event secretary before the start of the advertised time of the trials as published in Bloodlines Magazine and website.
- There will be individual familiarization runs before each size division for AGI-A and AGII-A and eligible AGI-B and AGII-B dogs only. Familiarization runs will be done only on lead and only one attempt at each obstacle will be permitted during these runs.
- A concession stand will be available for breakfast and lunch both days.
- Exhibitors are responsible for cleaning up after their own dogs.
- Inside crating available. Arena is heated, but as with any arena it may still be cold inside, depending on the weather. Electrical outlets are available to exhibitors at the trial site on a first come, first served basis.
- No entry fee will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme &/or dangerous weather conditions, an act of God, public emergency or any other cause beyond the control of Hutchinson Agility Training Team, Inc., or the show committee.
- Confirmation letters will be mailed.
- Building will be locked each night, no dogs allowed overnight or unattended.

#### **Motels:**

**It is the exhibitors' responsibility to check with motels on current dog policies. Please keep your dogs quiet and please clean up after your dogs!**

### HOW TO USE THIS ENTRY FORM:

#### 1. Licensed Conformation classes consist of:

**A. Regular Classes. Classes for intact dogs:** Puppy (6 mos., under 1 yr.); Junior (1 yr., under 2 yrs.); Intermediate (Senior) (2 yrs., under 3 yrs.); Adult (3 yrs. and up); Breeder/Handler (6 mos. and up, handled by breeder or member of breeder's family); Champion; and Grand Champion.

**B. Altered Classes. Classes for altered dogs.** Altered Puppy (6 mos., under 1 yr.); Altered Junior (1 yr., under 2 yrs.); Altered Intermediate (Senior) (2 yrs., under 3 yrs.); Altered Adult (3 yrs. and up); Altered Breeder/Handler (6 mos. and up, handled by breeder or member of breeder's family); Altered Champion; and Altered Grand Champion.

**C. Junior Showmanship Classes. Consist of:** Pee Wee (over 2 yrs., under 4 yrs.); Sub-Junior (4 yrs., under 8 yrs.); Novice Junior, Open Junior (8 yrs., under 13 yrs.); Novice Senior, Open Senior (13 yrs., under 18 yrs.)

2. All entries must be submitted on the current "Official UKC® Entry Form". You may use one entry form to enter the same dog in more than one activity on the same weekend.

3. Use a separate entry form for each dog entered in a club's event.

4. Mail all completed entry forms to the Event Secretary listed under the event, unless otherwise specified. Make checks payable to host club.

5. Obedience Trials, Agility Trials, Rally Obedience Trials, and Weight Pull events are open to all UKC recognized breeds and mixed-breed dogs with a valid Limited Privilege number. The Coursing Aptitude Test is open to all UKC registered and Mixed bred dogs with a valid Limited Privilege number.

6. **We want you to keep the points earned at UKC Licensed events. Important things to remember:**

- Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at [www.ukcdogs.com](http://www.ukcdogs.com) or call the Dog Events Department at (269) 343-9020. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)

- **All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Limited Privilege number.**

- All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.

- To be eligible to enter into the Breeder/Handler class, you must be one of the breeders of record, or a member of the immediate family of one of the breeders of record. Immediate family includes: spouse, parent, step-parent, child, step-child, brother or sister, so long as the handler is not a professional handler as defined by UKC Rules and Regulations.

### WAIVER

All events are held under the Official Rules and Regulations of the United Kennel Club, Inc. Absolutely no alcoholic beverages, illegal drugs or firearms will be allowed on the grounds or in the buildings on the day of a UKC Licensed event. UKC, its agents and employees, and the host club assume no responsibility for any loss, damage, or injury sustained by spectators or by exhibitors and handlers, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians. UKC and the host club are not responsible for loss, accidents or theft.
